## Hilton says OK



The downtown Vancouver conference center and hotel development moved another step forward as Hilton Hotels Corporation's Finance Committee confirmed its

commitment to the project today.

"Hilton's confirmation solidifies what we have already known," says FaulknerUSA Development Division president **Greg Williams**. "Hilton is committed to this project and appreciates its financial feasibility."

"This project and the economic impact it will bring has been a long time coming," says **Steve Burdick**, the city's economic development manager. "The momentum is building and we are very close to making this project a reality for Vancouver."

The \$70-plus million project would put a 225-room seven-story hotel and conference center south of Esther Short Park on facing Columbia Street.

Although the major decision—Hilton's agreement to operate the hotel and convention center once built—was the last major hurdle, there are a few hoops to go through before the project is a done deal.

Approvals are required of the city's Public Facilities District and the Clark County Public Facilities district, which has tentatively agreed to earmark \$500,000 a year from the county's share of state tax rebates for public facilities, and resolution of a law suit filed by a local group of hotel operators which could block the project entirely.

And, finally, construction must begin before the end of this year for the city's PFD to realize the city's share of state tax rebates.

Without Hilton's agreement to proceed the downtown project, nearly eight years in the making would have died.

## County's final recommendations on Comp Plan to be discussed in open houses

The Clark County Long Range Planning Division will present draft recommendations for updating the county Comprehensive Growth Plan with three open houses, the first at 6 p.m. Wednesday, Sept. 10.

The draft plan attempts to guide growth and land use in the county and its seven cities over the next 20 years. Completion of the revised plan is expected by the end of the year.

The first open house is in the Public Service Center. The second, at 6 p.m. Thursday, Sept. 11 is in the Old Camas High School, 1612 NE Garfield Street, Camas. The final open house is at 6 p.m. Tuesday, Sept. 16, p.m. the Battle Ground Senior Citizen Center, 116 NE 3rd Avenue, Battle Ground.
