## Fort Vancouver High School student traffic court is the real thing for student infractions

The judge, clerk, prosecutor, defense attorney and members of the jury will all be students of Fort Vancouver High School when their first student traffic court, in cooperation with the Clark County District Court, convenes at 7 p.m. Monday, Nov. 3.

So, too, will be the defendants.

Fort Vancouver High School students charged with traffic infractions can ask the county district court to refer their cases to the student court for disposition.

When sentence requirements are completed, the cases will be referred back to district court, where the cases can be dismissed.

Because Fort Vancouver High School is a magnet school for students interested in law, it has its own courtroom.

There are some 900 student courts across the nation, seventeen of which are in Washington.

"We hope to expand the student court program throughout the county," says district court commissioner **James Swanger**. "The courts not only give students real experience in the courtroom, but also help reduce the district court's caseload."

The student court will convene the first Monday of the month throughout the school year.

## Cathlapotle plankhouse ceremony to be followed by Chinook seafood lunch

The 11 a.m. Saturday, Nov. 1, ceremony celebrating the beginning of construction of the Cathlapotle plankhouse in the Carty Unit of the Ridgefield Wildlife Refuge is free, but the seafood lunch, prepared by the Chinook Tribe, is \$30.

The lunch is one of the fund raising efforts of the local Lewis and Clark Bicentennial Committee. The cost of the plankhouse is covered by donations and volunteer workers as the community begins actual work on projects that will be celebrated in 2005.

The plankhouse is a \$300,000 replica of long houses seen by the Lewis and Clark Corps of Discovery, in 1805 and 1806, north of Ridgefield. According to records, Lewis and Clark found several plankhouses at Cathlapotle and estimated a population of about 800 at the time. Archaeologists suggest that Cathlapotle was the site of an Indian village for at least 3,000 years.
