# Bank of Clark County makes \$30,000 contribution to Historic Reserve Trust

To assist the restoration project for the Red Cross Building in Vancouver Barracks, the Bank of Clark County has made its largest community contribution to date, \$30,000, to the Vancouver National Historic Reserve Trust.

Bank vice president and commercial loan officer **E. Hunt Coracci** says: "The Historic Reserve will play a pivotal role in enhancing the economic vitality of our region. We are already a major supporter of the trust and contributor to its Celebrate Freedom programs."

The Red Cross Convalescent House, in the heart of the West Barracks, will be the first building to be restored. It was built in 1918 to serve World War I soldiers and later became an Army service club.

With Bank of Clark County's gift, only \$153,000 in private financing toward the total of \$1,050,000 in restoration costs remains to be contributed.
