## Nurses hit Southwest Washington Medical Center with unfair labor practice charge

The Washington State Nurses Association, representing about 1,000 registered nurses at Southwest Washington Medical Center, today filed an unfair labor practice charge against Southwest Washington Medical Center with the National Labor Relations Board.

The state Nurses Association has represented SWMC registered nurses for collective bargaining since August 1998.

The contract between the nurses' union and the medical center expired May 3. Efforts toward mediation thus far have failed, according to association spokesperson **Anne Piazza**. However, another session with a federal mediator is scheduled for Monday, Sept. 8.

**Barbara Frye**, director of labor relations for the state association, said the medical center has openly supported a decertification effort in violation of the National Labor Relations Act, including providing assistance to employees in circulating a petition to decertify the union.

Not so, answers **Ken Cole**, medical center spokesperson: "We intend to vigorously defend the charge, for which we believe there is no basis. The medical center is well aware of, and has complied with, federal labor laws and intends to continue doing so." Cole says he is not aware of any decertification petitions.

Cole adds that management will continue to bargain in good faith and will be at the mediation session Monday, adding, "Management negotiation teams have been negotiating for six months and have reached many decisions during that time."

According to Cole, the average pay for registered nurses at the medical center is \$55,000 a year. Piazza says that the hourly rate for registered nurses with five years' experience is about \$22 an hour.

Piazza says the sticking points in contract negotiations aren't current wages but a guarantee of future wages. The nurses want to know what they will be making in future years, she says.
