## **All kinds of financial aid available for matriculating Clark Students**

During the 2005-2006 academic year, the Clark College financial aid disbursed \$19 million to 4,602 students, according to dean of enrollment services **Michal Montoya**. This includes \$969,216 in scholarships, Montoya said. Of Clark's 11,658 currently enrolled students, 40 percent have received financial aid.

Financial aid includes grants, scholarships, student employment, including work-study programs, tuition waivers, sponsored programs, and student loans. In addition, Clark allows students to pay for tuition in three interest-free installments, according to Montoya.
