La Center alligator taken into custody

A three-foot long alligator was taken from a pond near La Center today and taken to the Southwest Washington Humane Society for transfer to an animal rescue organization.

The gator is thought to have been abandoned as a result of a state law that became effective last month declaring alligators as potentially dangerous animals. Except under very limited circumstances, according to the new law, individuals may not keep alligators or other potentially dangerous animals.

The alligator was captured by **Bob Austin** Bonneville Power Administration, and Clark County Animal Control officer **Tippy Rutherford** on BPA transmission right-of-way near NE 38th Avenue and 379th Street.

Austin, who had worked with alligators and crocodiles in the Everglades in Florida after graduate school from Central Michigan University in the 1970s, volunteered for the mission.
