Partnering with two primary care clinics to provide case management services for diabetes patients.

Collaborating with the Clark County Tobacco Coalition to adopt voluntary outdoor smoke-free policies and develop a smoke-free housing guide.

The Healthy Vending Campaign, Fit Pick, for worksites, schools and community organizations.

The community walkability campaign advocating pedestrian-friendly environments.
