

# Clark Public Utilities, Clark County and the City of Vancouver kick off \$1 million energy conservation effort

Clark Public Utilities, Clark County, and the City of Vancouver have joined together to offer a pilot energy conservation program for eligible homes and businesses in the Hazel Dell area and Fourth Plain corridor, thanks to \$1 million in federal stimulus funding awarded by the state.

**Larry Blaufus**, senior manager of energy services and technologies for the utility, said the program, called Project Energy Savings, would get under way in March when Hazel Dell neighborhood volunteers will canvass the pilot area between Northeast Minnehaha and Northeast 68th streets east of Interstate 5.

In Rose Village and Fourth Plain Village, staff from Americans Building Community and volunteers will canvass these neighborhoods in the pilot area, which is bounded by I-5, SR-500, Burnt Bridge Creek, and Fourth Plain.

Volunteers will share energy conservation information and schedule an energy audit, which could lead to financial assistance for weatherizing homes and small businesses of those who meet eligibility requirements.

These neighborhoods will kick off Project Energy Savings with an Energy Fair from 5 to 8 p.m. Wednesday, Feb. 24, at Hazel Dell Elementary School, 511 N.E. Anderson Road. Clark Public Utilities energy counselors and weatherization contractors will discuss and demonstrate energy-saving measures for the home. There will be door prizes, refreshments and children's activities.

A Clark Public Utilities energy counselor will provide an energy conservation kit along with a complete analysis of qualifying homes and businesses. The analysis will provide a detailed energy consumption report and customized action plan for efficiency improvements. The audit will identify ways to save money and energy, and include a list of available cash incentives for efficiency improvements. Among the conservation improvements are installation of insulation, duct sealing, and air sealing.

The program is open to those who live in the targeted areas with combined household incomes that are above requirements for low-income weatherization programs. For a family of four, that's \$3,675 a month. For a two-person household, the minimum is \$2,428. Customers with lower incomes may be eligible for other conservation programs offered by the utility and Clark County.

This program will pay for some energy conservation measures. Clark Public Utilities has weatherization and appliance rebates, as well as low-interest loans for additional improvements.

Clark County is accepting applications to fill a vacancy created by the recent resignation of District Court Judge **Rich Melnick**, who was appointed by Gov. **Chris Gregoire** to succeed retiring Superior Court Judge **Robert Harris**.

To qualify, candidates must be registered voters of Clark County and lawyers admitted to practice in the state of Washington. They must obtain and complete a questionnaire from the Board of County Commissioners' Office on the sixth floor of the Public Service Center, 1300 Franklin St. There is no charge for the questionnaire, on paper or on disk, but it is not available by mail.

Completed questionnaires must arrive on paper at the Commissioners' Office by 5 p.m. on March 1. Email and faxes will not be accepted.

After the deadline, a list of qualified applicants will be forwarded to the Clark County Bar Association and to the Washington Women Lawyers for preference polling. Results of the polling will be provided to a screening committee, which will interview each applicant. The committee will recommend a group of finalists to be interviewed by the commissioners, who are expected to make an appointment by March 31.

The screening committee will include County Administrator **Bill Barron**, retired Superior Court Judges **James Ladley** and **John Skimas**, and local attorney and past president of the bar association, **Jean McCoy**.

"District Court is a key element of our local law and justice system," says Barron. "This process has served us well in identifying excellent candidates in the past, and we look forward to filling this vacancy very quickly."

Under state law, the newly appointed judge must run for election at the next general election, which will be held in November.

### Walk and Knock breaks record
